## Ongoing Public Exhibition Venues in Calistoga

1. WEST AMERICA BANK (multi- or 1-person show) 1110 Washington Street, Calistoga	Six 8-11 foot walls plus one 4 foot wall. Needs at least 3 large pieces for the walls behind the tellers because of viewing distance. Walls are off-white.
2. BANK OF AMERICA (multi- or 1-person show) 1429 Lincoln Ave., Calistoga	Warm white walls. One long wall with a picture rail at eye level accommodates twelve medium sized pieces. Three shorter walls take several larger pieces.
3. CALISTOGA ROASTERY (1-person show) 1426 Lincoln Ave., Calistoga	A popular and very busy café. Can accommodate ~8-12 medium pieces or fewer large pieces. The walls are yellow.

Each exhibit hangs for a two-month period and includes a reception on the first Thursday of the first month during the exhibit (your venue curator will let you know this date). We encourage you to visit the venues for yourself to see what the spaces look like and visualize how your work would fit. Exhibition Fee: 25% of Sales to the Calistoga Art Center

The Calistoga Art Center does not process sales of the artwork; buyers must contact the artist directly. The artist is responsible for handling sales of the art, paying the sales tax, and paying the 25% commission to the Calistoga Art Center. If a piece is sold and removed prior to the end of an exhibit period, the artist must replace the piece.

**STATEMENT OF UNDERSTANDING:** As a exhibitor of the Calistoga Art Center, I understand that any establishment and/or the CAC has the right to refuse, for any reason, to display my artwork. I have read and understood the above and agree to these terms.
