### **Exhibition Fee: 25% of Sales to the Calistoga Art Center**

The Calistoga Art Center does not process sales of the artwork; buyers must contact the artist directly. The artist is responsible for handling sales of the art, paying the sales tax, and paying the 25% commission to the Calistoga Art Center, either at the time of the sale or within one week of the sale. (This is a tax-deductible donation)

### **Artist Waiver and Hold Harmless Agreement:**

I hereby agree that I, my heirs, guardians, legal representatives, and assigns will not hold the Calistoga Art Center, the exhibiting organization, its officers, employees or agents responsible for injury, loss, or damage, as a result of my participation in voluntarily displaying my artwork under the auspices of the Calistoga Art Center.

I acknowledge that whenever my artwork is placed for display by the Calistoga Art Center at any facility or location, it may be located in public access areas which may not be secure from theft, vandalism, or other possible causes of loss or damage. In addition, the artwork may be subject to damage from falling, fire, water, or other types of damage from any cause. As such, the risk of loss or damage to my artwork will be my responsibility to accept, or insure against.
